RE: Addendum no. 1 to Agreement dated 8 June 2007 regarding support to Mzumbe University

With reference to the Agreement between the Norwegian Ministry of Foreign Affairs (MFA) and the Government of the United Republic of Tanzania on development cooperation concerning the support to Mzumbe University dated 8 June 2007 (the Agreement), as well as the meeting that took place between the Ministry of Finance, representing Tanzania and the Royal Norwegian Embassy, representing MFA, on 21 December, 2007, regarding additional assistance to the programme "Norwegian Support to Mzumbe University 2006/07 – 2009/10" (the Programme), I have the honour of proposing the following for your consideration:

The Agreement shall hereby be extended until all obligations arising from it and from this Addendum have been fulfilled.

MFA shall, subject to Parliamentary appropriations and the terms and procedures of the Agreement and this Addendum, provide an addition to the Grant not exceeding NOK 2 500 000 (Norwegian Kroner Two Million and Five Hundred Thousand) to be used for agreed Programme activities in the planned period January to June 2008.

The disbursement shall be made upon signing of this Addendum and upon MFA's approval of a written request from Tanzania based on the financial needs of the Programme. Along with the request, Tanzania shall state the cash balance of the Programme and a clear budget breakdown, and submit statement of bank balances for the Programme from the bank.

This Addendum changes the date for submitting the final report referred to in Article VII, clause 5 and the financial statements referred to in Article VII, clause 4 in the Agreement to 31 December 2008. All other conditions of the original Agreement remain the same.

If the foregoing is acceptable to Tanzania, I have the honour of suggesting that this letter together with your written acceptance shall constitute an Addendum no. 1 to, and an integral part of, the Agreement, which shall enter into force on the date of your counter signature.
